ELECTIVES: 4 HOURS						
May be selected from any upper- or lower-division area except activity courses in LEIS and PE and lower-division AERO and MLSC. Twelve credit hours earned in advanced AERO and MLSC, exclusive of credit earned for summer camp, may be included in the 120 hours.						
Other Requirements:						
1. A minimum of 50 percent of the business hours required for a degree must be in residence at OSU.						
2. Forty-five hours of upper division courses required.						
3. The student must indicate language proficiency as evidenced by						
a.) 15 hours of study of a single modern foreign language with a minimum grade of "C" or, b.) study in a foreign country approved by the department head and 10 hours of study of a single modern foreign language with a minimum grade of "C" or c.) five hours of intermediate or advanced modern foreign language courses with a minimum grade of "C", or d.) passing an approved Oklahoma State University examination. *Note: Students who must complete all 15 hours of language courses (i.e., who cannot demonstrate language proficiency equivalent to one course) will need at least 131 hours to meet all degree requirements.						
Additional State/OSU Requirements – At least: 60 hours at a four-year institution; 30 hours completed at OSU; 15 of the final 30 and 50% of the upper-division hours in the major field completed at OSU. Limit of: one-half of major course requirements as transfer work; one-fourth of hours earned by correspondence; 8 transfer correspondence hours. Students will be held responsible for degree requirements in effect at the time of matriculation and any changes that are made, so long as these changes do not result in semester credit hours being added or do not delay graduation. Degrees that follow this plan must be completed by the end of Summer 2020.
